G. CARDAROPOLI AWARD 2025

To honour the memory of Dr **Giuseppe Cardaropoli**, SidP Active Member, who dedicated his professional life to periodontal and implant research and to the sharing of knowledge amongst younger colleagues, the **Italian Society of Periodontology and Implantology (SidP)** together with "[Fondazione Giuseppe Cardaropoli](#)" established the "**Giuseppe Cardaropoli Award**" for the best presentation at its [Annual Congress 2025](#) (Rimini, 13-15 March) in the session called "**RESEARCH FORUM**", offering to clinicians and researchers the chance to present and discuss their own scientific studies in the field of Periodontology and Implantology.

Both clinical research and basic sciences research are eligible.

Abstract Submission

Abstracts should be **written in English language**. **Deadline for submission will be February 17th 2025** only and exclusively using the appropriate preformed form available on the website www.sidp.it (section *Competitions and Awards*) from September the 1st 2024.

Only on-line submitted abstracts will be accepted and considered for evaluation.

The works (up to a maximum of 10) deemed most deserving by the Coordinators of the Research Forum 2025 will be presented in the form of **oral communication** within the "**Research Forum-G. Cardaropoli Award**".

The presentation should occupy a space of 10 minutes with 5 minutes of discussion.

The work must be original and not have been published and/or presented previously in other scientific events. In particular, scientific works that have already been submitted and / or accepted for evaluation to any scientific journal by the **expiry date of the call** will not be taken into consideration by the Coordinators.

The above editorial lines are mandatory for the evaluation of the manuscript by the Coordinators.

The Evaluating Committee (the two Coordinators of the Research Forum 2025 and personalities from the academic or professional world) will judge the abstracts by evaluating: the clinical relevance, the English language standard, the objectivity, the materials and methods and their suitability with respect to the objectives. established, the congruity of the conclusions with respect to the results obtained, the ethics, the scientific value, the potential clinical significance and the originality of the work.

The other scientific studies received for participation in the awarding of the Prize may be selected for presentation in the form of posters again in the context of the Society's 2025 Annual Congress.

The confirmation or not of acceptance will be communicated by e-mail by the Secretariat of the SidP by 28 February 2025.

The presentation will not be accepted if the presenting Author would not be pre-registered in the Congress.

Presentation and discussion will be in English or in Italian language.

Failure to pre-register at the Congress will result in the cancellation of participation in the session. Failure to present the work in the dedicated session of the 2025 SidP Congress will not allow publication in the journal *JOMI* edited by *Quintessence*. Each Author may appear as presenter in only one abstract, but as co-author in an unlimited number of abstracts.

Abstracts of previously published or presented studies cannot be sent.

During the event, the Evaluating Committee will assign the "G. Cardaropoli Award" to the best work presented, recognizing the Author who submitted it for **SidP one-year free registration**.
